PUBLIC SKATE PROTOCOLS

- 1 Online registration is now MANDATORY for all Public Skate sessions. This allows YOU to know if spaces are available and to reserve your spot early. If you do not have access to online registration or need help, NO problem!! Please call, email or visit our facility in person. We are happy to register skaters for you.
- 2 TIA "NO TOUCH POLICY": Due to the COVID-19 pandemic, and per the Maine CDC 6-foot rule, for the health and safety of TIA staff and skaters, TIA has set in place a "No Touch Policy". In order to staff Staff will ONLY assist skaters who are unable to rise unassisted dues to a fall/injuy. For this reason, skaters must have on-ice skating experience or be accompanied with someone who does.
- 3 Please arrive at the rink no more than 10 minutes before your scheduled session. This allows staff to keep groups separate from each other for the purposes of contact tracing.
- 4 All who visit TIA, including skaters, parents, guardians, etc., are required to wear a face covering and observe the 6 foot rule. When waiting in line outside or standing by your vehicle in the parking lot, you must wear your face covering and observe the 6 foot rule. (Family members who live in the same household are exempt from the 6-foot rule.)
- 5 Skaters are required to wear a face covering at all times, including when engaging in on-ice activities.
 - Please Note: Per the CDC, shields alone are not an acceptable barrier unless combined with a face covering.
- 6 Skaters are to be dropped off/picked up outside the rink and should come prepared to take the ice.
 Family/Friends/Spectators are <u>NOT</u> allowed in the arena. Very young children may **briefly be accompanied by one adult, wearing a facemask**, for assistance prior to and immediately following their session. We encourage parents to join their children on the ice!
- 7 As a safety precaution, TIA is controlling access to the building and as such, we appreciate your prompt arrival for sessions.
- 8 ONLY sessions canceled 2 hours PRIOR to skills & drills session start time are eligible to receive a credit or refund. To cancel, please contact our office via email.
- 9 Upon your arrival, entrance to the building is through the front doors and once in the lobby, down the stairs to the left. Please look for the arrows.
- 10 Areas will be clearly marked 6 feet apart where skaters can put on and take off skates and leave their jackets, water bottles, shoes, etc. with their bag. **Boldly** label your water bottle with your name and leave on the bench with your belongings.
- 11 Upon entering the ice, skater will skate counter clockwise (entering the ice to the right), unless otherwise notified.
- 12 Skaters must exit the building within 10 minutes after their session has concluded.
- 13 Upon your departure, exit past the bleachers and through the side doors. *Please look for the arrows*.
- 14 TIA does NOT maintain a Lost and Found. Any items left behind will be disposed of. All personal items, i.e. jewelry, wallet, etc. should be left at home.
- 15 Consumption of food is not allowed in the arena.
- 16 Restrooms may be used with a maximum of 2 skaters per restroom allowed.
- 17 Gathering/Socializing in the lobby and/or restrooms is NOT allowed.
- 18 Skate sharpening is available upon reguest and by appointment only. (207) 808-5492

THE FOLLOWING ITEMS ARE NOT ALLOWED ON PUBLIC SKATE SESSIONS: Private Lessons • Hockey Sticks • Hockey Pucks • Head Phones • Carring a Child On-Ice • Pairs Skating *

* Pairs skating is ONLY allowed if you live in the same household.

MANDITORY: BEFORE ENTERING OUR FACILITY, ALL QUESTIONS ON THE TIA COVID-19 DAILY HEALTH CHECK MUST BE ANSWERED. You may do this from home or upon your arrival at TIA. For your convenience, the Q-code is also posted on the entry doors to our facility.

VIOLATION OF ANY ONE OF THESE PROTOCOLS MAY RESULT IN BEING ASKED TO LEAVE OUR FACILITY.
